9. Ranch


- a. Minimum of 4 entries in each walk-trot ranch class or they will be combined
- b. 3 classes: Ranch Pleasure, Ranch Riding and Ranch Confirmation
- c. Divisions will be Open and Walk-Trot (18 and under, 19 and over depending on entries)
- d. These classes will be added in at the end of the day.
- e. For the buckle series you still must follow year end award requirements
- f. Carol suggests saving Ranch Trail for the Silver Show and adding in Ranch Showmanship.
- g. Stating we will allow cross entering on all paperwork.

10. We spent a lot of time discussing how to make paperwork in the office easier. Trying to get all the information we need and how to compartmentalize it without adding more steps in to the check in process.

- a. We did realize slowing down would help keep things legible. Even if that meant the members had to wait a little longer.

- c. And what isn't working like not being able to read notes in the payment box, which payment amount is the correct ones, if it was really paid or not paid, how people are cashing out at the end of the day.
- d. Moving forward we will not be allowing charges and all open checks need to be filed out at the end of the day.
